## Hong Kong, China Rowing Association Terms and Conditions for the Rowing Centre User

#### 1. Points to Note for Centre User

- Those who use <u>Sha Tin Rowing Centre (STRC)</u> / <u>Jockey Club Shek Mun Rowing Centre (JCSMRC)</u> and its facilities during opening hours must be an authorized Centre User.
- All users must <u>present their own valid Centre User Card</u> upon the request from staff or inside the Rowing Centres and before boat outing at anvtime.
- HK\$30 will be charged by HKCRA for the cost of re-issuing a User Card.

#### 2. Requirement for Skills

All users must pass Star 3 Sculling / Sweep or above skill test. Please provide the copy of the equivalent certificate or approval documents at the first time of the registration.

#### 3. Notes for New User

- Please provide a passport size photo when submit the completed Centre User Form.
- Please complete and submit the "Physical Fitness Readiness Questionnaire" together with the Centre User Form.

#### 4. Concession User

Concession fee applies to full-time students aged 25 or under at a recognized educational establishment in Hong Kong or Persons with disabilities. The applicant should provide valid student card or any supporting document for verification.

#### 5. Payment Method

- All payment can be made in crossed cheque and made payable to "HONG KONG, CHINA ROWING ASSOCIATION"; OR
- ♦ Direct transfer the payment to the (HSBC) at bank account "002-6-187443". (Please send the original transfer receipt or reference number to the HKCRA Office together with the application form.)

#### 6. Application Process

- Centre User card will only issue when payment is settled and the provided information is completed and corrected.
- ♦ Normally, it takes 14 working days for issuance of card.
- HKCRA will inform applicant to pick up the card by WHATSAPP: 6214 0829.

#### **8.** Anti-doping Policy

All Members, and rower support personnel of the HKCRA and those taking part in activities organized by the HKCRA or any Club, shall comply fully with the latest Anti-Doping Rules of the Sports Federation & Olympic Committee of Hong Kong, China, the Hong Kong Anti-Doping Committee and the Anti-Doping Bye-Laws of FISA. Any person in breach of this provision or assisting in a breach by others will be subject to disqualification in accordance with Rule 72 and suspension or termination of membership in accordance with Article 14 of the Articles of Association. The Board reserves the right to communicate details of any breach to the Sports Federation & Olympic Committee of Hong Kong, China and the Hong Kong Anti-Doping Committee and FISA.
