To promote Board Rowing, the Association is now launching the "Board Rowing Trial Trip" to **ALL** affiliated Clubs. We are delighted to inform you that an "one off" promotion is offered to all Affiliated Clubs in experiencing board rowing and together let's bring rowing to a wider audience!

The Trial Trip is offered on a first-come-first-served basis, the application will start **from 10 May 2021 to 30 June 2021**.
