5. The estimated delivery date from confirmation of order shall be stated.
6. Validity of the tender shall be 90 days from the deadline closing date.
7. Replies received after the closing date will not be considered.
8. HKCRA reserves the right to accept partial supply or all items in this Tender.
9. All prices quoted shall be in Hong Kong dollars (HK\$).
10. The company should indicate one year warranty period for all equipment.
11. Prices provided in the quotation shall include all charges including manufacturing, supply, door-to-door delivery, insurance and related costs. ***Please incorporate all costs - including shipping, door to door delivery, insurance etc. - into the unit cost and not as separate tender items.*** Please don't indicate insurance and door to door delivery costs separately in the Tender form. 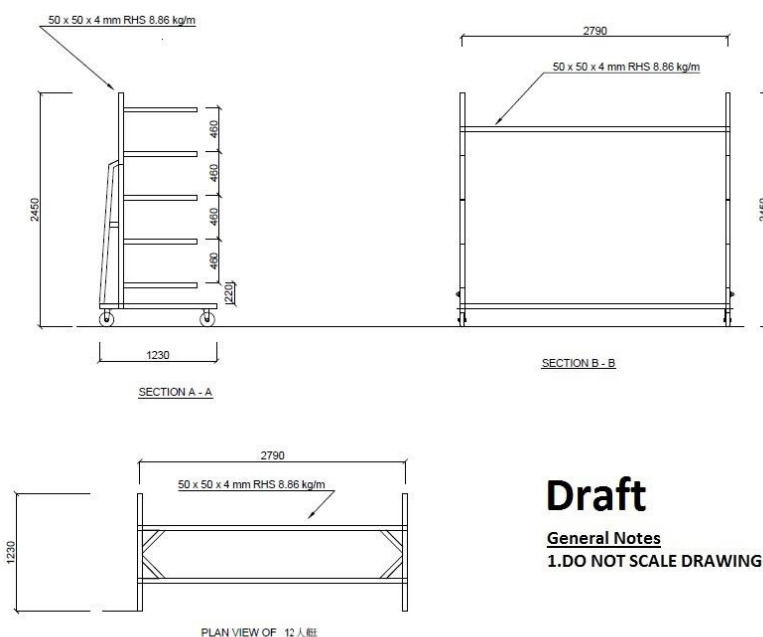
